Upon submission, the Owner(s) above authorize MAACC to access the specified Lot to gather pertinent information and inspect the construction progress. The MAACC will make efforts to reach the Owner during any site visit.

For your protection, the MAACC strongly urges that work begins only after the Committee approves this application and the approval letter is received.

IMPORTANT: Any changes or modifications to the exterior appearance of the structure or improvement project after obtaining initial written approval from the MAACC must be submitted to the MAACC for subsequent written authorization before beginning the additional modifications. If the change involves different materials or colors, the Owner must submit new materials and color samples with an updated application for change. Allow up to twenty (20) days for approval of changes.

By submitting this document, you understand and agree that if you fail to follow the approved plan, the MAACC will require you to remedy the non-compliance at your expense. Additionally, changes made before or without the written approval of the MAACC relieve the Committee of all liability. All records concerning any project will be made available to legal counsel for residents of the filing as needed.

For the proposed project, include two copies of the site plan for the building lot, drawn to scale, displaying all lot boundaries, adjoining roads, easements, restricted areas, and setback distances. Additionally, provide structure or improvement plans with complete specifications and all four exterior elevations, including the original and finished grade of the land about the structure or improvement. Ensure the written description covers exterior materials and colors, exterior lighting, walls, fences, and other structure or improvement placements. Finally, mark the location of any new structures on the building lot for review by the MAACC.
